## A History of Excellence

When Georgia attorney Adam Malone's father began handling personal injury cases more than 50 years ago, the legal system was tilted heavily in favor of corporations, hospitals and insurance companies. Holding these powerful interests accountable for mistakes and wrongdoing was next to impossible, but Tommy Malone challenged them anyway and often prevailed against all odds.

Over the years, Malone Law's success has not only helped countless victims whose lives would otherwise have been destroyed, it has also transformed Georgia's legal landscape. Following in his father's footsteps, Adam Malone in 2008 handled the case that convinced Georgia's Supreme Court to strike down the state's \$350,000 cap on noneconomic damages in medical negligence cases and guarantee victims the right to a trial by jury. Over his 20-year career, Malone has won more than \$500 million in judgments and settlements for his clients, with many verdicts weighing in at more than \$20 million.

"When I was a little kid, I wanted to be like my father because I saw what a difference he made in people's lives," Malone says. "He was a respected pillar of the community, and he inspired me to dedicate my professional life to the cause of justice for people who have no other recourse."

Now, it's Adam Malone who is making a difference in people's lives—by listening to their heartbreaking stories and, if necessary, fighting for them in a court of law. "The reward in this work isn't the money, it's the opportunity to improve the life of another human being," Malone says, "a person the system might otherwise forget about or ignore."

Since 2010, Malone has been included in *The Best Lawyers in America*® and has previously been named *Best Lawyers*® "Lawyer of the Year" for Medical Malpractice Law – Plaintiffs in Atlanta. ## OFFERING HOPE WHEN TRAGEDY STRIKES

To Adam Malone, lawsuits involving catastrophic injury and wrongful deaths aren't just about seeking justice for his clients—a strong verdict can also prevent other people from suffering a similar fate and even correct injustices in the legal system itself.

"Since the dawn of corporate medicine, preventable medical errors have been, and continue to be, the third leading cause of death in the United States," Malone says. "Litigation is the only tool available to ordinary patients and their families to do something about this—to discover the dangerous practices and hold wrongdoers fully accountable. When these folks come to us, we get answers, we expose the problem, we take care of our clients, and we get the attention of those with the power to make changes so that society is a little safer for the rest of us."

Following in the footsteps of his father, legendary personal injury attorney Tommy Malone, Adam Malone has been holding powerful medical institutions and negligent corporations accountable for more than 20 years. Chosen to the Top 10 Super Lawyers honorees in the state of Georgia, Malone and his team have won more than \$500 million in judgments and settlements for his clients, including \$49 million for a student who suffered brain damage in a trucking disaster, \$24.5 million for a teenage athlete whose leg was unnecessarily amputated, \$16 million for a newborn child who was misdiagnosed and suffered a liver transplant, and numerous other eight-figure recoveries. He has also tried cases involving spinal cord injuries, traumatic brain injuries, burns and other calamities.

"When people come to me, the harm is usually devastating," Malone explains. "They are disabled, they can't earn an income, they've lost their health insurance, government programs won't meet their needs, and they see no way out. Sometimes, the outcome of the case literally determines if they live or die. And if they live, the outcome always determines what the quality of their remaining life will be."

To help ensure that his clients receive the compensation they deserve, Malone Law has developed an innovative approach to medical malpractice and other catastrophic injury litigation that involves deep investigative research and a team of independent medical advisors—including a board-certified ER physician and nurse/attorney—who help determine the underlying facts in any given case. And in the courtroom, Malone and his team are known for their ability to explain complex medical and legal matters in plain language a jury can understand.

Most important of all, Malone's clients know that he is singularly dedicated to improving their quality of life, whether they or a loved one has been unnecessarily injured or killed. He is particularly passionate about helping parents whose children have had their lives cut short or compromised, and he understands the emotional toll such tragedies take on a family.

"A case is not a transaction, it is a relationship—one we develop throughout the course of litigation and beyond," Malone says. "We cannot tell another person's story without understanding who they are, without caring for them. People in these situations need to be held and heard."

They also need a good attorney—one who is well-versed in malpractice law, who understands the systemic challenges involved in medical litigation, and who has successfully tried medical cases in court. Malone's record of excellence in catastrophic injury cases is unparalleled in the state of Georgia, and he intends to keep it that way by fighting each case as if someone's life depends on it.
